



## **Abstract**

In a setting where the value of inventions is not verifiable until after its introduction to the market, the paper characterizes the optimal contract to delegate the invention process to an expert. We consider both simultaneous and sequential invention processes and show that in both cases the optimal contract takes the form of an option.
