

Abstract

Discounted Cash Flow (DCF) analysis is one of the most popular tools in valuation problems, which are, arguably, the most critical issue in finance. Unfortunately, this technique is full of conceptual flaws that have many undesirable practical implications. In the talk we will explore these shoertcomings and suggest some tentative solutions.
